3. Application Procedures:

- 1) Obtain the application form from the General Office in person during office hours or download it from the school website (www.ccckeito.edu.hk).
- 2) Submit the application form to the General Office in person during office hours, together with the following documents or e SSPA Applicants can also apply through<<the SSPA e-Platform>>:
 - a. 'Application Form for S1 Discretionary Places' issued by the Education Bureau
 - b. A photocopy of the student's Identity Card
 - c. Photocopies of student's school report cards from Primary 5 to 6 (including the benchmarking framework overleaf)
 - d. Photocopies of student's service certificate(s), award certificate(s) and extra-curricular activity certificate(s), both issued by school and organisation(s) outside school
 - e. Two self-addressed stamped (\$2.2) rectangular envelopes bearing the student's name

Remarks: Applicants are not required to submit any recommendation letters from the primary school.

5. Selection criteria: The school will admit students according to the criteria and weighting below.

8. Release of Application Results:

The school will notify all successful applicants of their inclusion in the Successful List for Discretionary Places by phone and mail on 31 March 2026. The final admission result will be announced together with Central Allocation result on 7 July 2026. Parents are not required to conduct any enquiries prior the announcement of the results.
